Artist Live Work Studios - ARTIST-IN-RESIDENCE FEE PER WEEK

STUDIO 2: \$950 /week 295 sq ft

STUDIO 3: \$1,100 /week 362 sq ft

STUDIO 4: \$1,450 /week (if 2 Artists - \$725 ea) 553 sq ft

STUDIO 5: \$1,450 /week (if 2 Artists - \$725 ea) 590 sq ft

Shared Studio - Two artists may share a studio (studio #4 or studio #5), however, both must fill out a complete application and provide their individual application materials.

Application materials:

1. Resume
2. Description of proposed work during residency
3. Documentation: Link to website or:
 - Visual Artists: 10 - 15 images of current work: MAX: 2MB per file
 - Image Data: Artist Name, Title of Piece, Media, Dimensions, Date
 - Audio /Video: Up to 5 minutes time-based, Mac/PC compatible
 - Writing: Maximum 20 pages for fiction or non fiction: Maximum 20 pages poetry
4. Any special needs or health issue information that may assist us with your residency experience.
